Dear Griff,

It was a great pleasure indeed to receive your letter here in the new world. Your views are those of the vast majority, and shortly I will send you my account of the way in which the EDCL was brutally put out of business by Big Brother to the East.

I recently wrote a letter to the Cambrian News asking for a boycott of the sale, and have been fighting its closure for three years or more using various tactics. This fight has been

made difficult because over a hundred approaches to the various Colleges of the University of Wales asking for a role as a scholar have been rebuffed or ignored. However, I have recently tried again and have received some good support from Sir Goronwy Daniel, who agreed that the sale was unethical and unimaginative. Gareth has also been fighting bravely from "Speit Isaf", Llanddeiniol, SY23 5BG, but has been out of work off and on for three years since being forced to leave the EDCL.

Never a day passes without my thinking back to the EDCL days, and I would give my eye teeth to return there again.

Among the things I have tried in the past are 1) Fighting through all the University's procedures, from College Court and Council to University Court. 2) Contacting the Privy Council. 3) Writing to M.P.'s and newspapers. 4) Writing repeatedly to Principals Gareth Owen and K. O. Morgan. 5) Appealing to I.B.M. in the U.S.A. 6) Trying to raise the money to buy the EDCL by a Bank Loan.

My letters to the Principals were ignored and are still being ignored. Sir Goronwy Daniel wrote to the Principal on my behalf, but I have heard nothing.

I wrote to the Chairman of the U.G.C. repeatedly, with very brave support from Gareth. We both suffered for this and have been put out of work for rebellious tendency. Sir Peter mentioned that the closure was "inevitably subjective".

I am still willing to fight until hell freezes over, but coolness and organisation is needed at this critical stage. The safest way of preventing the closure would be a purchase by the

People of Wales, which is Supreme Authority in its University. It is a matter of appealing to the People in a well organised way, of seeking legal ways of preventing the sell-off, of organising resistance in a positive way. Among the things I have tried in the U.S. is an approach to Foundations, appeals to Journals, and so on. However no journal would accept my advertisement. Even Orville refused to help.

All that is water under the bridge and there is time for one more big effort. 1) Taking out full page adverts in the Cambrian News and Western Mail. The editor of the Cambrian News might do this free of charge, and seems to be sympathetic. We appeal for as much as people can afford. 2) Set up a Trust Fund for the appeal with the help of Plaid Cymru at Aberystwyth. 3) Set up a Steering Committee to go for Euro funds to buy the EDCL. 4) The Committee to make systematic appeals to industry. 5) Involve the T.U.C. of Wales and the Labour Party, if it will help. Similarly the Liberal Party. 6) Obtain the active support of Sir Goronwy Daniel. 7) Obstruct the present sale by trying again to get the Old Building listed. According to Gareth he got it listed before but threats were issued from the College and the National Trust gave up. Gareth can be contacted to find out what really happened. 8) Use Legal Injunction and use the media (TV and Radio) to get help on your side. In this way isolate the elite in the College.

I am afraid that people like John Thomas and Prof. Mansel Davies have no guts for the fight, and the Welsh M.P.'s have so far been ineffective. Mansell can use his connections with Geraint Howells to initiate questioning in Parliament, and Parliamentary pressure on the College. People like the Leader of the Opposition have been stunningly silent, and this is no good. Plaid Cymru M.P.'s should mobilise in defence of the EDCL as a focal point of Welsh Pride, and the Eisteddfod's advanced Organisational capability could be mobilised to raise funds, and force the College to take the EDCL off the open market, and sell it at a reasonable price to the People of Wales.

I will try to mobilise support from the BBC in Wales. I believe that Sir Goronwy would chair the steering committee. There would be no point in expecting help, however, from Jeremy or Graham. They are interested only in themselves.

The enclosed letter shows my latest attempt at getting a job in the University. If my CV can be of any help I enclose it. The obvious things, like a letter writing campaign to the present Principal, should be done. He has hundreds of pages of material from Gareth and myself suggesting uses for the EDCL.

I also suggest an appeal to the European Parliament through your Euro M.P.'s, and use of the European Court. I have exhausted all U.K. appeals mechanisms by going to the Privy Council. This effectively refused to get involved. Records of appeals are with the Privy Council Office, Whitehall.

I suggest that of the Steering Committee is set up, it look for a good barrister like Lord Elystan, willing to give his services free and start obstructing the sale by a series of injunctions, for example on the basis of historical interest. Half the battle is in getting the

old building re-listed, so it can't be sold. An appeal can be lodged with the European Court, thus delaying the sale indefinitely.

I have put my money where my mouth is and have left some scholarships to the University in my Will. Despite this my requests for employment are being ignored.

I am prepared to work in the EDCL without a salary, and to stock it with equipment, getting research off the ground again.

I will get down to writing the appeal for the Cambrian News, and ask the Editor for a free page every week for the appeal.

Many things can be done once the steering committee is formed. Getting the Old Building listed could stop them in their tracks.

P.S. If enough people want to help the campaign, they must organise themselves and get the help of other organisations. Then the appeal could be launched. Once the appeal is underway help could be got from concerts, and events and so on to raise funds for the purchase by the People, or for the legal battle. Football and rugby matches could be arranged, Dick would help with athletics events. The schools could be mobilised to raise funds, and many more things like this. The only people who won't help are the academics in power. The trick is to get the appeal on TV. I am sure that the Farmers Union of Wales would lend a hand, the National Union of Teachers and so on.

Thank you for your recent letter. I enclose a copy of the Will, in final draft. If the University is agreeable in outline I will forward the Memorandum concerning the scholarships.

Thank you for your opinion which I value. However, as the enclosed letter to Sir Goronwy Daniel shows, the idea that I take a Chair in an English University is not unfortunately realistic in the present climate.

As Secretary of the University I would be grateful if you could direct the enclosed to Sir Goronwy in his capacity as Chairman of the recent committee on the University's future. As Secretary and Registrar, I think it is important to let you know that Sir Goronwy has interceded on my behalf with Aberystwyth, a College in which I served with unusual academic success for fifteen years.

I wish to write to you in a friendly spirit of cooperation and constructive thought about the University's future. I think that I have much to offer but that I need affiliation for the reasons set out in the enclosed letter. Sir Goronwy's views must surely be taken seriously. It is a matter of Public knowledge that he believes the only real future is New Federalism. In correspondence he agreed with me that the sale of the EDCL at Aberystwyth is unimaginative and unethical. I have put forward yet another proposal to Aberystwyth to try to avert this sale, but again with no reply. The College has not even replied, apparently, to Sir Goronwy's suggestion that I be given a role there. With all due respect this is not a promising response to reinvigorated

I wonder whether Federal authority can be used to try to stop the sale of the EDCL and to obtain a reply from Aberystwyth to my various communications. I have several positive things to bring to the University, including a new Institute for Basic Research which is in the final stages of being set up as a Trust. I have the ability to attract outside funding, and in the past I have brought in some quarter of a million pounds. My latest research work will probably be funded by the AFOSR.

I suggest that you could bring in to being a small federal committee to be chaired by Sir Goronwy, of which you would be secretary. Other Members could include Mr J. Henry Jones of Adult Education in Swansea, a former Member of the Council of Wales who has been gravely concerned about my situation for

a number of years; and Mr Dafydd Wigley, M. P., who has often written to Aberystwyth and Bangor on my behalf in the past. This could bring up proposals for a solution which would allow me to work inside the University to its benefit.

A list of some twenty or thirty academic supporters has already been forwarded to you and to Sir

Goronwy, who has transmitted it to Aberystwyth. This material was sent to you in connection with the Honorary Senior Fellowship, information which you specifically requested in your letter of late 1988. The proper procedure for further consideration of the post, honoris causa, would to put it before the University's Academic Board. This procedure could also be followed in the enclosed request for adjunct professorship. There are precedents in the Universities of London and Lancaster. In the latter a position, honoris causa, was awarded to me by the University's Council after a simple suggestion by Dr. P.V. E. McClintock. I have also held visiting positions at Cornell, Pisa, I.B.M., London and Dublin.

Thank you very much in anticipation for your further consideration.

Sir Goronwy Daniel, Letterston, Dyfed, Wales, Dear Sir Goronwy,

Thank you for supporting my various job applications in the past year or so. 1 have applied for over 200 posts in the U.K., U.S., and Canada, and have made a further 150 or so direct enquiries.

I know that I have been short listed for Endowed Chairs, such as the Plane and Carlson Chairs, for Full Professorships, and once or twice as Head of Department (Chairman). My applications for Assistant Professor have been met with incredulity because of my qualifications. The American Chemical Society has refused to put me on its list of candidates for post-doctoral positions, believing in good faith that a more senior position would be more appropriate.

I am sure you will understand that the senior positions for which I am apparently considered are few and far between, and extremely competitive. I am nearly always considered "over-qualified" for junior positions. As a result I now face another "open-ended" period of unemployment. During this period I could probably continue to produce work of international standard, but for any scientist prolonged isolation is not desirable. Scientific institutions presumably still have an interest in the support of scholarship.

After my Visiting Professorship at I.B.M. to October 1987 I was unemployed for fifteen months, during which time I produced some thirty published scientific papers refereed in scientific journals of repute. Generous support during this time arrived in the form of an Honorary Research Fellowship from the University of Lancaster, through the good offices of Peter McClintock, and a Visiting Academic position in the University of London, with the enlightened support of Konrad Singer and David Heyes.

Enrico Clementi, I.B.M. Fellow, has expressed his growing concern at the situation, and has persuaded the company to provide temporary contractual support until mid-June, 1989. I was recently given an I.B.M. award for my publication activities.

Research activities with David Heyes, over a trans-Atlantic bitnet system constructed privately, have resulted in the possibility of a grant award. In view of the failure of conventional institutional support, I

wonder whether you would consider some form of ad hoc affiliation for me in your Institution, following the precedents set by Lancaster and London. This could perhaps take the form of an adjunct research fellowship with partial institutional support. I would undertake to compete for research funds from outside sources, with some form of institutional affiliation allowing me to do so officially. These funds would be administered by the institution. Affiliation would allow me dignity as a scholar and any publications would be attributed to the institution. Affiliation is important also for interchange of ideas, access to libraries and so on.

I have pleasure in enclosing my C.V. and list of publications, honours and awards. Thank you in anticipation for your consideration, and best regards.

Thank you for your letter and enclosure. I am sorry that you did not apply for the chair in Bangor. It would either have resulted in the chair or a recent case for which fresh evidence would have been available. Well you certainly have all the qualifications for long fights. You have everything except what such qualifications deserve-a senior academic nost. I very much hope that the people supporting in Cornel will be successful. You are much too intelligent not to realize that yourfight against any of the Colleges in Wales can only be a right and a contribution for accountability and you might as well do that from a paid post as well as from an unpaid one.

I would very much like to see that Article in the N.Y.T. Our Government is based upon the priciple-How Can Demo cracy be contained from a historical position of Monarchy and Feudalism. All our Institutions are Feudal in structure with some democratic seepage. The U.S.A. has its birth in popular consent with constitution and institutions trying to answer the question- How can we give expression to Democracy. The U.S.A. Freedom of Information Act is quite unthinkable here even under Labour which in the past has been as centralist and as secretative and Civil Servant dominated as any of the Parties.

The One World Programmes on T.V. this week has been a wonderful mental uplift. Listing to the Scientists has been marvelous for clarity and objective analysis. In about the middle of the week they brought on the politicians. I could not bear to lister to the "all things being equal" tripe so I switched off. Given the good sense of the Prince of Wales and his speech perhaps we would be better off with a monarchy if the quality is right. After here democracy-as-democracy benefitano one outside of the Cabinet and they are subservient to Mrs big  $^{\text{T}}$ . Nost of the 630 M.P. are bored to death not knowing what the hell to do with themselves. They do not even have the right to a seat let alone where to sit nor do they have thay right to speak. If you are lucky to catch the consent of the speaker you speak for a lengith of time according to your Parliamentary status not according to your democratic status. If a member of the Front Bench gets on his feet or if a member of the Privy Council stands up he may be in Parliament by virtue of 50 votes majority but Allan Rodgers with the largest majority in Parliament would have to sit down.
